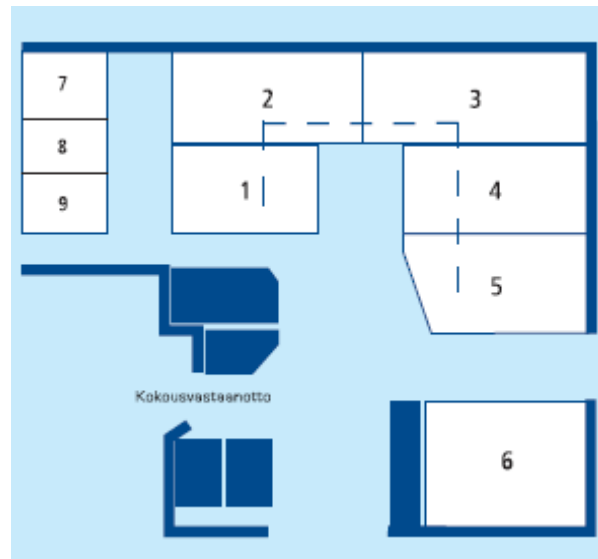

DATE AND VENUE OF THE EXHIBITION

The exhibition of the Camure-8 & ISMR-7 conference will take place on 22 to 25 May 2011 at the Naantali Spa Hotel (<http://www.naantalispa.fi/>). The exhibition will be open during the conference hours (Monday to Wednesday).

The location of the exhibition area will be on the first floor of the hotel in meeting rooms 1, 2 and 3 as shown in the picture below. Also the poster sessions will be in the same rooms. The parallel session will take place in rooms 4 and 5.



STANDS

The stands will be arranged in form of tables and chairs. The size of the tables is 80 x 135 cm. Several tables can be combined if there is enough of space, this depends on the number of exhibitors taking part in the conference. Please specify in the “Exhibition contract” how many tables and chairs you will need.
